

HON. KASAIJA CLARIFIES ON RISING COMMODITY PRICES

The recent increase in the prices of essential commodities is a result of events that have occurred outside Uganda. Uganda is a netimporter of intermediate raw materials used in production of items such as refined cooking oil and laundry bar soap. The Minister for Finance, Planning and Economic Development, Hon. Matia Kasaija, clarified as follows;

1. The effect of COVID-19 restrictions across the world disrupted supply-chains leading to higher transport costs and shortage of intermediate raw materials used to produce items such as soap, cooking oil and others. In the recent past, global economy has faced high shipping costs, a shortage of shipping containers, and higher fuel prices; leading to supply shortages globally. In addition, an adverse weather condition in South America has led to low production of wheat and edible oils.

- 2. The full opening of economies globally following relative containment of COVID-19 has led to a rapid rise in aggregate demand for a number of fast-moving-goods (FMGs), beginning with oil, yet production levels had been constrained by COVID-19 restrictions. This has led to increase in prices everywhere in the world.
- 3. Lastly, the situation has been worsened by the Russia-Ukraine conflict which has further disrupted supply of oil, cereals such as wheat, corn, and sunflower oil, as well as essential metals like aluminium and nickel. The two countries are major producers and exporters of these commodities.

As a result of the above factors, prices of several commodities and services in Uganda have increased significantly and raised overall inflation. The affected commodities include cooking oil, soap, fuel, and education services.

UGANDA HOLDS 5TH ECONOMIC GROWTH FORUM

The Ministry of Finance,
Planning and Economic
Development holds an annual
Economic Growth Forum to
identify Uganda's key growth
challenges and develop
policy solutions to stimulate
the economy and promote
sustainable inclusive growth.
The economic growth forums
also provide evidence, growth
policies and strategies that
inform the national budget
priorities.

This year's Forum was held under the theme: "Economic Resilience, Recovery and Resurgent Growth".

Key points of discussion also hinged on ensuring that inclusive economic growth results into productive employment, poverty reduction and human development.

The 5th Economic Growth
Forum was officially opened
by the Minister of State
for Planning, Hon. Amos
Lugoloobi, who said that
although Uganda's economy
has been resilient and is
projected to grow by 3.8% in
FY 2021/22, the country needs
to achieve and sustain much
higher growth to realise
the medium and long-term
development aspirations.

Under the theme of using trade to drive the recovery, the following were recommended;

- i. Supporting the Private
 Sector to benefit from
 the regional markets such
 as AfCFTA, by offering
 export credit schemes to
 prospective firms which
 have successfully exported
 to regional communities.
- ii. Partner States of the EAC should consolidate all the Non Tarrif Barriers (NTBs) and address them as a region so as to exploit opportunities from regional integration.
- iii.Partner States of EAC
 should finalise the ongoing
 EAC common external tariff
 review and revise the EAC
 rules of origin to reflect
 industrialisation realities.
- iv.Review and subsequently implement the Uganda National Exports Strategy.
- v. Support the institutional set up to promote exports, for instance by providing information about market availability and accessibility, e.g. Uganda Export Promotion Board.
- vi.Diversify the export base to include more value added exports.
- vii. Provide the Private
 Sector with the necessary
 infrastructure to
 produce competitively

e.g. finalisation of
Export Processing
Zones (EPZs) and other
key infrastructure like
electricity with the
necessary kilowatts.

viii. Improve quality and standardisation of exports

Under the theme of inclusive economic growth, it was recommended that focus should continue to be put on improving foundational skills learning (reading, writing and numeracy) because they are very critical for the job market.

As part of the activities for the 5th Economic Growth Forum, Permanent Secretary and Secretary to the Treasury, Mr. Ramathan Ggoobi, launched a book titled "Beyond Recovery- Policies towards Resurgent Growth in Uganda". The book addresses four challenges namely; managing transition from growth slowdown to robust recovery and accelerated growth in the coming years, increasing the productivity of labour and capital, growing exports and expanding access to different markets and pace and nature of structural transformation in Uganda.

PRESIDENT MUSEVENI LAUNCHES PARISH DEVELOPMENT MODEL




On 26th February, 2022, in Kibuku District, Bukedi sub-region, President Yoweri Museveni launched the Parish Development Model (PDM) as a last mile approach for organising and delivering public and private sector interventions aimed at wealth creation and employment generation at the parish level as the lowest economic planning unit.

The Parish Development Model will ensure support for more Ugandans to join the money economy and consequently increase their demand for goods and services.

This FY 2021/22, Government provided UGX 200 billion targeting every parish to access UGX 17 million as a revolving fund for members of the village SACCO.

Next Financial Year 2022/23, Government will provide a total of UGX 1,059.4 billion, in which each of the 10,594 parishes in the country will receive UGX 100 million as revolving fund specifically under the two pillars of agricultural value chain development (production, processing and marketing) and financial inclusion.

Objectives PDM





Under the PDM, a Parish Chief will carry out the overall administration and management of a Parish unit in the Local Government. The argument is that Parish Chiefs know their communities well; the residents therein and the economic hardships they face. With this, a Parish Chief is the right person to guide and help implement the Parish Development Model. Government will also provide sufficient training to the Chiefs especially in financial management.

Over the years, Government has come up with similar programmes to eradicate poverty, create wealth and prosperity and cause socio economic transformation which haven't worked. But unlike the other initiatives, the PDM goes down to the parish which is the lowest administrative unit of the Central Government. The adoption of the PDM will extend to the Parish level the programme based planning,

PARISH DEVELOPMENT MODEL WILL DELIVER ECONOMIC TRANSFORMATION

Government of Uganda launched the Parish Development Model (PDM) as a flagship project under the National Development Plan (NDP III) to catapult 39% of the country's homesteads who are stuck in subsistence economy into the money income, through various profitable ventures.

budgeting and delivery approach. Parish action plans, budgets and reports will be prepared, coordinated and managed by the Parish Chief/Town Agent and Parish Development Committee (PDC) which will be the technical arm of the Parish Council.

How will the model work?

PDM has seven pillars, all aligned to National Development Plan III. These are;

- ▶ Production, storage, processing and marketing; the Government plans to roll out digital platforms for provision of farm inputs (e-vouchers), extension services (e-extension) and quality certification (e-certification) at the parish level.
- ► Infrastructure and economic services; public and private sector institutions will be mobilised to provide services at the parish level including; community access roads, safe water, produce markets, power connection and free internet to the community.

- ► Financial inclusion; improving access to financial services, extending loans to the currently excluded section of the population across the country, helping people to understand and practice the economics of running a viable/productive household enterprise to create 10,594 vibrant parish economics and drive local economic development across the country.
- Social Services; these include; primary health care, education, access to clean water, transport and communication.
- Mindset change and crosscutting issues like gender, environment and disability; this will emphasize the value of work and enforce a work ethic.
- An integrated information management system; to support community profiling, data collection, analysis, tabulation, storage and dissemination, at the parish level.
- Lastly, the governance and administration pillar.



What are the benefits of PDM?

Under the Infrastructure and economic services pillar, communities will get the following services;

- Accessible community roads
- Improvement of bridges on community roads
- Upgrade community local markets
- Extension of safe water for domestic use
- ► Extension of power to communities
- Creation of free internet zones in communities

In the financial inclusion pillar, the overall goal is to enable participation of subsistence households in the financial sector.

PDM will support a wide range of financial solutions (savings, credit, insurance, transfers, etc) to subsistence households in order to enhance incomes, smoothen consumption, build assets and reduce vulnerability to shocks.

In the social services pillar, the resources transferred will be appropriately planned for by the Local Governments to;

- ► Construct and equip health centre (HCII)
- Recruit critical staff as well as extension workers needed
- Strengthen infrastructure /facilities management
- Provide and maintain safe and accessible water points
- Support functional Village Health Teams (VHT)
- Construct/upgrade community primary schools
- Provide logistics and equipment for institutions (Schools, Hospitals, and Health Centres)

With proper implementation of the Parish Development Model, Government's efforts to increase household incomes and the quality of life for all Ugandans as envisaged in NDPIII and the country's path to Vision 2040 as well as the attainment of the NRM's economic vision for Uganda and the 2030 SDGs will be addressed.

PARISH DEVELOPMENT MODEL TO UPLIFT 3.5 MILLION HOUSEHOLDS

Goal

To move 3.5 million households from the subsistence to monetised economy.

Fund Size

UGX 1.05 trillion (UGX 100m per Parish)

Transmission Mechanism

The parish is going to be the vehicle for data gathering, area-based enterprise selection and development, co-operatives and financial services development, community mobilisation and mindset change.

The money is going to fund production, processing and marketing of agricultural produce.

LOCAL TOURISM PLAYERS AND ENTRY OF DRC TO BOOST LOCAL AND REGIONAL TOURSIM

After many years of marketing Uganda as an international destination, Ministry of Tourism, Wildlife and Antiquities, has embarked on a collaborative relationship with the private sector, to make Uganda attractive and affordable for every tourist; local and foreign.

After two years of COVID-19 pandemic lockdown, Government realised that domestic travel is very viable if marketed as a separate entity. This realisation has motivated the ministry to bring in domestic players in the tourism sector to market Uganda.

The ministry kicked off the domestic tourism promotion dubbed "DTF Easter 2022" this Easter holiday, by engaging established players in the sector to offer affordable rates to Ugandans during the festive season. They include Uganda Hotel Owners Association, Domestic Tourism Forum comprised of leading domestic tourism service providers like Breathtaking Uganda, Travel Neza, Umoja Conservation Trust, Vilakazi Safaris, Ikorom Safaris, various domestic airlines plying the local routes like Aero Link, Bar Aviation, public transport providers and several leading regional tourism clusters.

While the promotion covered the Easter Holiday, Minister of State for Tourism, Hon. Martin Bahinduka Mugarra, is optimistic that Ugandans will tour their homeland beyond the holidays. He observed thus "we are launching the Easter holiday getaway packages that will be used during the Easter holiday period for Ugandans to go and recharge in various destinations across the country. In each of these destinations,



we have also identified some moderately priced lodges and hotels that the public can take advantage of for great Easter packages using the 'DTF Easter 2022' promo code".

The benefits of this domestic tourism campaign is to partner with local stakeholders to come up with packages that are tailor made specifically for local visitors through leveraging their unique travel needs and interests. Some of the packages will include lower park entrance fees, free children packages, affordable air travel, affordable accommodation, etc.

Regionally, tourism and conservation got the much needed boost when Democratic Republic of Congo (DRC) joined the East African Community at the end of March. It is good news because the most endowed place in the region is stacked between Uganda, Rwanda and DR Congo. However, DRC has been bedevilled by insecurity especially in the eastern area which hosts Virunga National Park, which is shared with Uganda and Rwanda. The entry of DRC implies the three countries can partner and secure the tourism corridor of Mgahinga, Bwindi and Virunga National Parks.

DR Congo's Virunga National Park endangered mountain gorillas, hosts chimpanzees and golden monkeys. These same species migrate to Rwanda and Uganda periodically, which necessitates a synchronised handling of tourists among the three countries. One such example of mountain gorilla families trotting the three regional parks; Volcanoes National Park in Rwanda, Virunga National Park in the DRC and Mgahinga Gorilla National Park in Uganda, is the Hirwa family.

The three countries already collaborate under the Greater Virunga-Transboundary Collaboration (GVTC) agreement that was signed in 2015 among DRC, Rwanda and Uganda, as a framework of programmes, plans and activities to conserve a network of trans-boundary protected areas in Greater Virunga Landscape (GVL).

GVL was established to enable the three partner states sustain and conserve the shared resources within the GVL and as an important programme for endemic, threatened and migratory species that include lions, hippopotamus, chimpanzees, golden monkey, leopards, Okapi, golden cats, crown eagles, buffaloes, lesser flamingos, vultures, Rwenzori duikers, sitatunga, mountain gorillas, and elephants.

The travel and tourism industry represents a vital part of Uganda's economy and has a promising future. The Ministry of Tourism, Wildlife and Antiquities and the Uganda Tourism Board have unveiled campaigns like "Explore Uganda" that invites tourists - domestic, regional and international to rediscover the magnificence of the Pearl. "We are promising and inviting them to explore Uganda, the Pearl of Africa, for adventure of their lifetime", Ms. Lilly Ajarova, Executive Director of Uganda Tourism Board, declared.

MICROFNANCE SUPPORT CENTRE DISBURSES UGX 260 BILLION UNDER EMYOOGA

Microfinance Support Centre also operates the Emyooga fund; launched in August 2019 as part of the government strategies targeting informal specialized enterprises and individuals.

Eligibility for Emyooga

be a member of a SACCO operating in one of the 18 specialized enterprises of bodaboda, women entrepreneurs, carpenters, salon operators, taxi operators, restaurant owners, welders, market vendors, produce dealers, mechanics, tailors, journalists, and performing artists. Others are: fishermen, persons with disabilities (PWDs), veterans, youth leaders, and elected leaders at lower levels.

- ► Microfinance Support Centre has so far established 6,602 SACCOs and 205,710 saving groups. These are operating 4.1M accounts.
- A total of UGX 260bn has been disbursed and stimulated savings worth over UGX 55 billion.

STATE HOUSE COMPTROLLER LAUNCHES PRESIDENTIAL INDUSTRIAL HUBS COUNTRYWIDE

The State House House Comptroller, Ms. Jane Barekye, spent quarter three criss-crossing the country while launching the Presidential Industrial Hubs.

Industrial Hubs, a strategy of President Museveni to tackle unemployment and provide the youth with marketable skills such as bakery, block making and stone cutting, shoe making, tailoring and knitting, coffee and maize processing, welding, hair dressing, etc, started in Kampala in 2017 as Presidential Initiative on Skilling the Girl Child, under the office of State House Comptroller.

Between the years 2017 and 2020, over 10,000 girls were trained in different skills including tailoring, hair dressing, among others. At the end of the course, girls were given UGX 1,000,000, as start up capital, to start up small businesses and earn a living.

When the economy reopened in January, 2022, the President opted to decentralise the programme to all the 22 sub-regions/zones of Uganda and also to include the boy child for the first time as a beneficiary.

Ms. Barekye who has so far commissioned the hubs in Karamoja, Bunyoro, Lango, Bukedi, Busoga, Rwenzori, Kigezi, Ankole, Acholi and Bugisu, cautioned leaders against the leaders against promoting corruption in the hubs.

The Comptroller further stressed that the leaders should select beneficiaries who come from disadvantaged backgrounds and are well behaved. Local leaders were advised to form committees to oversee operations of the Hubs.



On his part, the Director for Presidential Industrial Hubs at State House, Eng. Raymond Kamugisha, said that they were starting operations with basic courses like bakery, block making and stone cutting, shoe making, tailoring and knitting but that after they have built some capacity, they would introduce some specialised courses.

In April, 2022, the Vice President, H.E. Jessica Alupo, handed over modern farming equipment to the leaders of Karamoja region. The Vice President who was accompanied by the Minister for Agriculture, Animal Industry and Fisheries, Hon. Frank Tumwebaze and the Minister of State for Fisheries, Hon. Hellen Adoa, handed over five sets of equipement, each set comprised of; a bulldozer, hydraulic excavators, a wheel loader, chain loaders, a motor grader, a vibrating motor roller, two water bowzer/tankers and two dump trucks.

In line with the agricultural sector under agroindustrialisation development programme, MAAIF procured assorted heavy earth moving equipment sets to revive the agricultural mechanisation in the country as key strategy of supporting farmers and processors.

The available assorted five heavy earth moving equipment sets are to develop infrastructure for increasing access to water for agricultural production (irrigation, livestock and aquaculture), opening, improvement and construction of farm access roads and to enhance

agricultural mechanisation services through bush clearing, land opening, ploughing, agro processing, value addition and support to farm structures development thus the ministry is using these heavy earth moving equipment sets to address the key water challenges in Karamoja.

The heavy equipment are serviced by a pickup, low bed carriers and mobile workshop vans and wheeled four tractors have been incorporated to ease farm activities in the districts to promote tractor services country wide.

ACCESS BY FARMERS

Once the heavy equipment unit is in the district, farmers access the services guided by the following principles:

The farmers request for the equipment by filling a requisition form (form is available and copy is in the guidelines booklet). All requests for use of equipment are routed through the respective districts to leverage rational scheduling of equipment.

Upon receipt of the request, the technical team visits the site and assesses the scope and quantity of

work to be carried out. This helps to determine the type of equipment to deploy, for how long and the costs involved.

Based on the assessment, discussion and agreement with the farmers, a Bank Payment Forms of the amount for payment is issued and to pay in the bank on Uganda Revenue Authority Account (the payment is Government revenue and must only be paid in the bank). The equipment will be deployed after payment is made.

COST OF EQUIPMENT

The services are on cost sharing between Government and the farmers.

The farmers will provide fuel (diesel) for the equipment to accomplish the assessed works: caution is taken to ensure that no contaminated fuel is used and that it is readily available when needed to ensure continuity. The amount of fuel is calculated according to the number of hours the particular equipment is to work. The heavy equipment has a meter to record the hours it has worked.

Pay a dry lease rates per hour rates (40% of the total utilisation rate per hour or day) for the different machinery as commitment to effective use. Approved dry hire rate are as follows;

GOVERNMENT COMPLETES 68 SEED SECONDARY SCHOOLS

Government started the process of commissioning Seed Secondary Schools on 28th December 2021. The first Phase of UgIFT project will deliver a total of 117 Secondary Schools; 48 Seed Secondary Schools have so far been commissioned in the sub-regions around the country out of a target of 68 Schools that are already complete.

UGANDA CELEBRATES WOMEN IN ICT & INNOVATION

International Women's Day is a global holiday that honors and celebrates the social, cultural, political, and economic achievements of women across the globe. As the world came together on this special day to recognise the impact women are making in the world and to raise awareness of women's equality and gender parity, the Ministry of ICT and National Guidance under its ICT Innovation initiative recognised women-led ICT Innovations (including inventions, products or systems) that have been developed in Uganda or by Ugandans.

The Ministry under the National ICT Initiatives Support Programme has a mandate to create a sustainable ecosystem for ICT innovations and to support ICT innovators and application developers and as such, the role women have played in pushing Uganda's agenda towards achieving this objective in the recent past cannot be emphasized enough. It's against this background that the Ministry organised a 6-day conference between 7th and 12th March 2022 at the National ICT Innovation Hub, Nakawa under the theme: "Celebrating Uganda's Women in ICT and Innovation".

The conference brought together innovators, entrepreneurs, students and women who have climbed to leadership positions at some of the most reputable companies.

PRISONS WARDERS AND WARDRESSES PASS OUT

The President and Commander in Chief of the Uganda People's Defence Forces (UPDF), Gen. Yoweri Museveni, officiated at the pass out ceremony at Kololo of 2, 018 prisons warders and wardresses that comprised 554 females and 1, 464 males who had undergone an eleven months training course at the Prisons Academy and Training School.

The President encouraged the Prisons Service to put up more prison and accommodation facilities noting that during a visit to Luzira prison last year, he had seen some good structures constructed by the prisons construction unit and called on them to utilise the same unit for putting up facilities across the country for the staff and inmates.

"If you can build houses, why can't you build more prisons? Let's stop the issue of crying for houses and buildings. The only demand should be for construction materials and may be recruiting more engineers", the President noted.

The President also advised the prisons service to build primary and secondary schools as well as medical facilities for the biological children of the prisons officers where they can study free of charge and the Government pays salaries of the teachers, and also receive medical attention.

H.E. Museveni, however, commended the Ministry of Internal Affairs and the Prisons service for reinforcing the force with more human resource. He noted that the problem in many African countries has been conceptual; pointing out that NRA/UPDF overcame that challenge by prioritising ideology.

He added that with a small economy, UPDF managed to defend the country from retrogressive forces and has never called the United Nations (UN) to defend Uganda.

The President expressed his gratitude and satisfaction with the exemplary standard exhibited by the graduands whom he equally praised for being very smart in the parade. He congratulated the leadership of the prisons service and the commandant of the Prisons Academy and Training School, Assistant Commissioner of Prisons Brenda Sana, for churning out good products.

The Commissioner General of Prisons, Dr. Johnson Byabashaija, thanked President Museveni for giving the green light for increasing the human resource in the prisons service.

Dr. Byabashaija assured the President that the growing of the cotton project to meet the target of one million bales is ongoing and will be achieved as more land is under acquisition in several parts of the country.

"With your help, Your Excellency, I am sure we shall meet the target of one million bales of cotton", he stressed.

Addressing the graduands, he urged them to be disciplined. He also assured the President that the officers of the prisons

services are very loyal and will always support Government's efforts to elevate Uganda into a middle income country.

He urged graduands to be disciplined and to be ambassadors of the Prisons Service.

The best warders and wardresses during the eleven months training course received gifts for their excellent performance. They included; Aryong Marshal Jude who was the overall best student while the best student in academics in the male category was Wolwenje Fred. Chemutai Flomena led in the female category.

The best male student in parade was Nyanga Eric Disi while the best female student was Christine Gassi.

MAKERERE UNIVERSITY TEAM WINS HUAWEI AFRICAN ICT COMPETITION IN SOUTH AFRICA

The ICT team from Uganda represented by university students from Makerere University won first place in the 2022 Huawei ICT Competition for Sub Saharan Africa having beaten 19 Countries and 36 teams and thus advancing to the Huawei ICT Global finals in China in May 2022.

The Huawei ICT competition is an annual international competition and communication platform for university students and higher education institutions within the Huawei ICT Academy programme aimed at promoting innovation among African universities and institutions of higher learning. Over 2,500 students compete annually.

A team of three Makerere University students code named, "Kilo-Tech" designed a QuickTest App for blood diagnosis without pricking of blood from the patient. The QuickTest App is an embedded mobile application system to diagnose blood diseases mainly HIV/AIDS and Malaria without pricking the patient.

The team was led by Rutanana Arnold, Nakyanzi Catherine (also Vice President College of Computing) and Nsengiyumva Wiberforce.

The key Benefit of the QuickTest App System

is to reduce blood disease diagnosis time. It is designed in a way that patient just logs in the app, place the thumb on the scanner, and get the test results.

The new Makerere students' technology is life-saving in terms of costs for Government they incur in buying kits for the hospitals and also saving costs on the patient's side in terms of transport to hospital and also reducing on stigmatisation because the patient will be afraid of the doctor or other people knowing their HIV status.

President Museveni congratulated and called upon the team to use those skills to innovate and create jobs for themselves and others.

Unreliable and insufficient power has come with several challenges in Karamoja Region, which range from; low industrialization, poor economic and social development. However, plans Government has of boosting Karamoja Businesses and Industrial other parks among development priorities. Karamoja Sub region is a semi-arid zone, located in the North-Eastern part of Ugandaandcoveringaround 27,000 sq. km covering over seven districts.

Government was thus concerned and gave priority to the expansion of the grid to ensure supply of stable, sufficient and reliable power in the region. The Uganda Transmission Electricity Company (UETCL) has constructed 132kV a Transmission Line (Opuyo-Monopoles Moroto) on covering The 160kms.

objective of this project is to ensure strategic expansion to meet the present and future electricity demands in Karamoja Region and surroundings. The its project has further seen the construction of a 132/33kV sub-station in Loputuk Sub-County in Moroto District transformers. two capacity of 40MVA and the upgrade of Opuyo Substation from 14MVA transformers to 40MVA.

Embarking on such projects has been efforts, concern and vigilance of the energy sectorthroughitskeyplayers namely; Ministry of Energy and Mineral Development, ERA, UEGCL, UETCL and UEDCL and the endless support of the Government of Uganda, as well development partners in solving the challenge of insufficient and unreliable power in the region and the Country at large.

All these investments by the Government of Uganda are drivers of economic development derived from the key focus areas for the energy sector in the National Development Plan (NDP) III. The Government focus for the sector is tailored on increasing proportion of Ugandans with access to electricity from 24% to 64% by 2025, increase Per Capita electricity consumption, transmission increase capacity of high voltage lines to 4354kms, 90% reliability of the grid, promoting the use of alternative sources of energy and strengthening policy, legal the and institutional framework.

I am confident that in the near future, power outage will become history in Uganda. However, to attain this, there is need for concerted efforts from the different stakeholders in the areas where the investments

are being implemented for their timely implementation and success. This therefore, calls for good political will from the local leadership, easy acquisition of land from the Project Affected Persons(PAPs) as well as attainment of the relevant required permits, for example for wetlands, forest reserves and traffic/roads.

This call is to limit the complicated and lengthy processes of acquiring land for new electricity transmission projects, which is a key bottleneck for projects because it has a direct bearing on the timeliness and cost effectiveness of implementing these projects, and slows down the intended economic and industrial growth of the country.

The energy sector players remain committed to providing a reliable and stable power network as we attain the NDP III goals.

UGANDA ACQUIRES ULTRA MODERN HELICOPTER MRO FACILITY

President Yoweri Museveni who is also commander in Chief of the UPDF commissioned a Helicopter Maintenance, Repair and Overhaul plant at the Nakasongola Air Force Base on 22nd January, 2022, that will also in the future upgrade chopper ware.

The MRO plant, the first of its kind in sub-Saharan Africa is a joint venture by the UPDF's commercial arm, the National Enterprise Corporation-NEC and Pro-heli International, a Russian Company and will be developed into a hub not only for the entire East African Region including UN Missions which use Russian helicopters but for the entire continent.

The Helicopter Maintenance, Repair and Overhaul -MRO plant will help Uganda save about 3.5 million US dollars that have been spent on transportation and overhauling one helicopter outside Uganda.

Maj Gen Sabiiti Muzeyi the General Manager Luwero Industries, a subsidiary of National Enterprise Corporation (NEC), said the facility with state of the art equipment is now fully operational.

EAC HEADS OF STATE ADMIT DRC TO THE COMMUNITY

On 29th March, 2022, East Africa made history when the East African Heads of State officially admitted the Democratic Republic of Congo (DRC) into the East African Community, effectively making it the latest and largest member of the trading block.

During the EAC Heads of State 19th Extra-Ordinary Summit held virtually, the summit considered the report of the Council of Ministers on the negotiations between the East African Community (EAC) and the Democratic Republic of the Congo (DRC) on admission of DRC into the EAC.

EAC Heads of State officially admitted the Democratic Republic of the Congo (DRC) into the

East African Community.

Kenya's President Uhuru Kenyatta, Chair of the Summit of EAC Heads of States announced the admission of DRC to the East African Community during the 19th Extra-Ordinary Summit of EAC Heads of State.

President Uhuru Kenyatta who is Chairman of the EAC Summit said DRC was first assessed by a council of the EAC ministers who concluded that the DRC is eligible to join the EAC, adding, that the aim of regional integration blocks is to strengthen our relationship, expand our markets for goods and services, create wealth, create more opportunities investment and services across without hindrance, and for easy movement of goods and services in the EAC.

PresidentYoweriMuseveni described the joining of EAC by DRC as a big event of great significance.

"I have been involved in these efforts for almost 60 years and this is really very pleasant that DRC has finally reconnected formally. What we call DRC now was part of Great Lakes. We were connected before colonialism. But when colonialisms came we got disconnected. It is good we are assembling. In 1960, towards the end, even Zambia and Somalia had applied to join the community" the President said.

GOVERNMENT SUSPENDS MANDATORY COVID-19 TESTING FOR ALL INCOMING TRAVELERS AT ENTEBBE AIRPORT

Ministry The of Health suspended the mandatory COVID-19 testing of all incoming travellers at Entebbe International Airport upon arrival with effect from 16th February 2022. This followed a Cabinet decision on 14th February 2022.

The suspension of mandatory testing is informed by:

- 1. The decline in positive cases identified at the airport
- 2. Reduction in global threat of new variants of concern (VOC) and therefore reduced risk of importation of VoC that will increase community transmission

However, the requirement for COVID-19 testing 72 hours before boarding for both incoming and exiting travellers remains in effect.

Health workers continue to screen all travellers both at arrival and departure and verify their COVID-19 test certificates.

COVID-19 VACCINATION COVERAGE STANDS AT 18.2%

The Government of Uganda continues to prioritise COVID-19 vaccination as a strategic intervention to protect the population from the severe effects of COVID-19 and control the spread of the pandemic including the new variants.

So far, **12,085,428** doses of the COVID-19 vaccine have been administered to the population.

To date, **10,315,951** of the 22 million priority persons have received the first dose of the COVID-19 vaccines and **2,236,544** are vaccinated using J&J vaccine while **1,769,477** have received the second dose of their initial vaccine and are therefore fully vaccinated.

Considering it requires only one dose of J&J to be fully vaccinated, Uganda has fully vaccinated 4,006,021 people (vaccination coverage of 18.2%)

UGANDA DEVELOPMENT BANK TO DISBURSE UGX 612 BILLION IN 2022

Goal:

To accelerate socioeconomic development through sustainable financial interventions in line with Uganda's development priorities.

UDB plans to disburse UGX 612 billion i.e. between January and December 2022.

GOVERNMENT CARRIES OUT RESEARCH ON UPE & USE FEES

The Ministry of Education and Sports with support from the Norwegian Embassy in Uganda is undertaking a countrywide study to collect empirical evidence on payment of fees and other school charges in public schoolsthatimplement the Universal Primary and Secondary Education programmes of Government. The study will help the Ministry to put in place a streamlined regulatory framework for school charges and fees.

The study seeks to address the following;

- ► The nature and extent of fees and other school charges in Universal Primary Education (UPE) and Universal Secondary Education (USE) implementing schools in the country.
- ► How school fees and charges are determined, collected, utilised, and accounted for in public primary and secondary Schools.
- ► Assess the level of willingness of parents and caregivers to make a monetary contribution to public schooling in Primary and Secondary Education levels.
- ▶ Determine the extent to which school fees and other charges are affecting the various categories of vulnerable children in the country.
- ► Lastly, what is the most feasible financing framework for UPE and USE based on the findings of the primary research and analysis of the policy framework for education financing in Uganda.

Status

- ▶ Data collection phase- Completed (46 districts sampled) as a representative of the whole country.
- ▶ Over 350 schools and more than 6,000 households have been visited.
- Ongoing data analysis stage of the study.

CASH TRANSFER PROGRAMME FOR TEACHERS IN PRIVATE PRIMARY AND SECONDARY SCHOOLS A SUCCESS

The Government of Uganda through the Ministry of Gender, Labour, and Social Development (MoGLSD) implemented the cash transfer programme for teachers, tutors, and instructors in Private Primary, Secondary, Vocational, and Health Training Institutions/Schools across the Country.

During the National Address on COVID-19 on 18th June 2021, the President of the Republic of Uganda H.E. Yoweri Kaguta Museveni directed the Prime Minister and the Minister for Gender, Labour, and Social Development, to identify persons who depend on daily income in urban areas especially Greater Kampala/ Cities and Municipalities of the Country, assess their needs during the lockdown period and identify interventions to take care of their needs.

Following the directive, the Ministry of Gender, Labour and Social Development (MoGLSD) implemented the Cash Transfer Programme that reached 497,848 persons within the targeted areas.

Given that the economy was already opening up, after consultations with several stakeholders including the Office of the Prime Minister (OPM) and the Ministry of Education and Sports - a decision was reached to target teachers in private primary and secondary schools.

The decision to target teachers in private schools was based on the fact that schools were closed since March 2020 when COVID-19 forced a nationwide "lockdown". While the vast majority of sectors were fully or partially reopened, the education sector remained closed.

By the time schools
started reopening on 10th
January 2022, teachers
in private primary and
secondary schools had
missed income for close
to two years, which made
it difficult for them to
provide for their families.
Even when they have
returned to school, they
still face challenges.

The purpose of the intervention was to support teachers whose income was disrupted by COVID-19 containment measures for close to two years, targeting One Hundred and Fifty Thousand (150,000) teachers each receiving cash worth Two Hundred thousand Uganda Shillings (UGX200,000) net with the taxes and withdrawal fees catered for.

The cash transfer programme to teachers in private primary and secondary schools was also to support the teachers as they return to the classroom and foster collaboration between the Government of Uganda and Civil Society in addressing the negative impacts of COVID-19 on vulnerable people.

The beneficiaries for the programme were selected based on the teachers that are not on the Government payroll, duly registered or licensed by the Ministry of Education and Sports, or have proof of submission of application for registration/licensing, those already teaching in a school licensed

or registered by the Ministry of Education and Sports, teachers who did not benefit from the June – September 2021 Government of Uganda (GoU) COVID-19 cash relief programme, and have a mobile money account (MTN or Airtel) registered in their name.

The Ministry of Gender closely worked with Kampala Capital City Authority, Chief Administrative Officers, Town Clerks of Cities and Municipalities to ensure that Education Officers and Head Teachers of private primary and secondary schools compile and upload data of eligible teachers on an online system.

Registration was done through the Ministry of Gender, Labour, and Social Development (MoGLSD) Online Data Collection System (https://cashrelief.mglsd.go.ug), by capturing the Head Teacher's details plus the respective school information which includes; the School Name, EMIS/License Number, Physical Address, Level (Primary or Secondary) and Administrative Unit.

The programme was a collaboration with the Ministry of Education and Sports, Ministry of Local Government, and National Information Technology Authority-Uganda, with support from GiveDirectly (GD) – an international Non-

Governmental Organization (NGO) that focuses on poverty alleviation and humanitarian relief via livelihood cash transfers.

The Prime Minister of the Republic of Uganda, Rt. Hon. Robinah Nabbanja, officially launched the cash transfer programme on Tuesday, 18th January 2022, at the Kampala Serena Hotel.

Since the Government of Uganda's decision in 1993 to liberalise the education sector, thousands of schools and institutions have been set up by private investors. In the secondary sub-sector, the number of private schools, at about 4000, is more than double the number of Government-funded schools.

Eligiblity

- Small businesses that have suffered financial distress arising from the effects of covid-19 pandemic and have potential for recovery.
- All small businesses operated by individuals, groups, partnerships and companies, employing 5-49 people and with annual turnover of UGX 10 million- UGX 100 million are eligible under the Fund.

Loan Tenure

Loans to eligible borrowers will be extended for periods of a minimum of six (6) months and a maximum of four (4) years, which shall include a grace period of a maximum of one (1) year depending on the nature of the project as agreed upon by the borrower and the PFI.

Costs Involved

Government component to the PFIs will be interest free.

The interest rate chargeable by the PFIs shall not exceed 10% per annum.

Facility fees charged by PFIs to eligible borrowers will not exceed 0.5% of the total loan amount and shall be a one-off charge.

Legal documentation, insurance fees and registration costs shall be borne by the borrower.

Security

The loan facilities under the Fund will be secured by collateral of any form as agreed upon by the PFI and the borrower in accordance with PFI's lending policies.

The Fund can be accessed from any financial institution supervised by Bank of Uganda.

Borrower application process

- Submit an application to any participating bank
- A copy of registration or certificate of incorporation or any other form of licensing; details of business ownership; number of employees; annual revenue projections from the business; and loan amount required.
